AND WHEREAS, a letter dated 26/08/2014 is received by this office on 26/08/2014 from the Institution requesting to Change College Name of the B.Ed College.

AND WHEREAS, the Institution has stated as follows;

"That the B.Ed College was started in 1986 with the name BRDM College of Education, P.B. No.26 Sakleshpur-573134, Hassan Dist. And the certificate of recognition of NCTE is enclosed (Enclosure No1).

Later the College was amalgamated with JSS Mahavidyapeetha, Mysore, (Jagadguru Shri ShivarathreeswaraMahavidypeetha) and the resolution was made to change the College only in the name as JSS Institute Of Education. (address – P.B. No. 26, Sakleshpur-573134, Hassan Dist.) Resolution copy is enclosed. (Enclosure No.2)

Even College change name was approved from the Government of Karnataka (Enclosure No 3) and also for the same was approved by the University of Mysore. Copies enclosed (Enclosure No 4) and for the same the authorized registration copy is also enclosed (Enclosure No 5)."

AND WHEREAS, the SRC in its 272nd meeting held on 1-2 September 2014 considered the institution letter dated 26.08.2014 and decided that (1) ask the institution to get the changes first registered by the registrar of societies. (2) If there is no evidence of transfer of title to lands and buildings in favour of the institution, then, ask for sale deed to that effect.

AND WHEREAS, before issuance of letter to institution, the institution has submitted its written representation on 10.09.2014 (with reference to website decision).

AND WHEREAS, the institution in its letter dated 08.09.2014 stating as follows:-
