SI. No	Good Governing Principles	Principles on which they are Based
1	Legality	All student teachers should have a voice in decision making. Either directly or through legitimate intermediate institution that represents their intention. Such broad participation is built on freedom of association and speech, as well as capacities to participate constructively.
2	Instruction and Production	Institution has a long-term perspective on good governance and human development. Along with the sense of what is needed for such a development, there is also an understanding of the historical, cultural and social complexities in which the perspective is grounded. Institution produce results that meet needs and demands of the student teachers by making the best use of resources.
3	Accountability	Decision makers in the institution are accountable to the public, as well as to stakeholders. This accountability differs depending on the institution and whether the direction is internal or external.
4	Transparency	Transparency is built on the free flow of information process. Institution and information are directly accessible to those student teachers are concerned with them and enough information is provided to understand and monitor them.
5	Fairness and Equity	Legal Frame works should be fair and enforced impartially, particularly, the laws on human rights. All student teachers have equal opportunities to improve or maintain their Wellbeing.
6	Compliance	Compliance in the institution refers to the adherence to regulations, standards and laws that apply to all aspects of operations. Compliance is part of institution and its main role is to direct efforts to ensure that stakeholders do not violate the rules and regulations.
